#### **Included In Price:**

- Miscellaneous fees such as individual transfers, passports, laundry, telephone, mini bar, alcohol, beverages and any food outside of meals supplied in tour
- Any documents/fees or visas/fees for non-US/Canadian citizens
- All other items and personal expenses not listed as included

**Accommodations:** Price is per person, based on double occupancy. When available, single rooms are often smaller than doubles and will be subject to an additional single supplemental charge of \$999 per person. Sar-El Tours will try to match roommates, but we can't guarantee one will be available. Roommates may be assigned as late as 30 days prior to departure date, and if one is not available or if you request a single room, the additional single supplemental charge will be applied.

**Payment Information:** Deposit of \$500(USD) per person is required no later than December 15, 2021. Final payment is required no later than February 14, 2022. Final payments made after February 14, 2022, and registrations received after February 14, 2022 must be accompanied by full payment plus \$100(USD) late fee.

**Cancellation fees:** Once registration is completed and up to 30 days prior to departure date, any cancellation is subject to \$300(USD) non-refundable administration fees. If your cancellation forces your roommate into having a single room, you will be charged for the single supplement. Cancellations within 30 days prior to departure date will be subject to a full payment of 100% of the total cost of the tour. Submit cancellation in writing. On or after day of departure, there will be no refund for any services not used.

**Travel Insurance:** We do not provide travel insurance coverage, medical insurance, or any other kind of insurance. It is up to the individual traveler to purchase their own coverage, if desired. One possibility is [travelinsurance.com](http://travelinsurance.com) or you can find any other company that you would like to use.

**Passport Validity:** Passports must be valid for at least six months past the date of your departure. Copies of Passports must be provided to us no later than February 1, 2022. Failure to provide your

passport information to us by this date may result in change fees or denial of travel. Make a copy of your passport and carry it separately from the original.

**Price Increases:** All prices quoted in this brochure are subject to change due to currency fluctuations, fuel surcharge increases, government taxes and fee increases or unforeseen circumstances.

**Fit to Travel Statement:** Travelers registering for the tour accept the responsibility for being in good health and able to walk and travel on the tour. Because many of the sites are not accessible to the physically challenged, those needing oxygen, wheelchairs, or other ambulatory assistance will find the tour extremely limiting to their experience. Please understand that it is probable that a negative PCR test will be required to board the plane and another one upon arriving at Ben Gurion Airport in Tel Aviv. It is also possible that more testing will be required during the tour-either PCR or Serological. Please check travel restrictions often for updates.

Any testing would add extra costs which are NOT included in the price of the tour. We do not know what the prices would be or what might be required in 2022. Again, you would be responsible for these extra costs, including quarantine or rescheduling of flights if required.

We strongly urge you to purchase insurance that will cover travel and/or any expenses related to COVID, including changes in flights, medical care, or quarantines.
